## FEDERAL COMMUNICATIONS COMMISSION ANNOUNCES AGENDA FOR JUNE FIRST SUMMIT ON SPECTRUM POLICY AND MANAGEMENT

**Washington, D.C.** – The Federal Communications Commission’s Public Safety and Homeland Security Bureau (PSHSB) today announced the agenda for the Summit on *Spectrum Policy and Management: Building Public Safety Communications* to be held on Friday, June 1, 2007, 9:00 a.m. – 1:30 p.m., in the Commission Meeting Room (TW-C305)

The Summit will include expert panels composed of representatives from the public safety community, government and the communications industry. The panelists will discuss issues related to the creation, implementation and management of public safety spectrum, as well as the benefits of enhancing public/private partnerships to support a nationwide interoperable public safety communications network.
